Employee Assistance Opportunity for Giving

This has been such a strange and stressful year. We now enter any building and no longer can we see the faces of our neighbors, colleagues, family, providers, waiters, clerks, etc. We must look deep into the eyes of those we encounter to read their expressions, mood, intent—even to determine if they are smiling or frowning. Have you ever looked that deeply into the eyes of your caregiver, wait staff, or housekeeper? Perhaps this is an opportunity for us to **take another look at those who help provide services and amenities at Glacier Hills and improve residents' lives...our employees**.

Our employees have experienced quite a variety of challenges this year, and some are continuing on to increase their education. Below are **a few facts about our employee support** that might interest and even surprise you:

1. We have awarded \$25,000 through our **Employee Scholarships** this fiscal year to 9 individuals on our staff. There will be more in the spring who wish to attend or continue in their educational pursuits.

- 2. More than 50 employees have received assistance totaling \$48,000 from the Employee Emergency Support program. The stories are private, and they are heartbreaking: lost jobs, decreased hours, mounting medical bills, failing cars. The fund balance is now \$23,000, and we are in need of additional charitable support.
- 3. Employees who bring their children to the Child Development Center have access to the **Tuition for Tots** fund. A recent large gift of \$423,000 has formed an endowment that makes a huge difference in being able to support our employees' children at the Center and provide affordable educational care. We wish to add to that endowment and support more employees' children in the future.

Would you take a moment to consider **supporting our employees with assistance for their education, emergencies, or child development**? Your support means so much to our employees, and we know our employees mean so much to you. Thank you for your consideration.
